**Re: Summary of Sahtu Land Use Plan Draft 3 Changes**

Dear Madams and Sirs,

As you know, on July 12 the Sahtu Land Use Planning Board (SLUPB) released Draft 3 of the Sahtu Land Use Plan (SLUP). This letter is to follow up on the email announcing its release and to summarize the changes since the previous Draft.

All Land Corporations and Band Councils will receive 2 paper copies of Draft 3, with wall-sized maps by early August. Included with this letter is an electronic copy of Draft 3 and all supporting documents. For all others interested in obtaining these files, they are available on the SLUPB website at: [www.sahtulanduseplan.ca](http://www.sahtulanduseplan.ca).

Please note that SLUPB staff and a Board member will hold community consultation meetings in Fort Good Hope in August/September. This will be the last round of consultations before the SLUPB holds a public hearing this fall from November 22-26 in Norman Wells. When both community consultations and the public hearing have been carried out, final revisions will be made to the Sahtu Land Use Plan before submission to SSI, the GNWT and the federal government for approval.

Your involvement in this final round of feedback will be important in helping the Board understand your community's interests and needs. We look forward to working with the Fort Good Hope leadership and community members to revise and finalize Draft 3 for final submission to all approving parties.

A number of significant changes have been introduced since Draft 2. In general, they are as listed below:

- Zone numbers and names have been revised to reflect the re-introduction of some old zones that were once removed and the inclusion of new ones
- All zone boundaries and designations have been refined based on GIS analysis of the values of interest for protection
- A number of the Conformity Requirements (mandatory conditions for development) in Draft 2 Special Management Zones (SMZs) have now been applied throughout the Sahtu Settlement Area in General Use Zones (GUZs)
- SMZs in Draft 3 have more focused conditions that are to protect the specific values of the zone



- The Fort Good Hope and Colville Lake Group Trapping Area has been recognized in the Background Report and the Plan as per its recognized status in the land claim
- A consistent 500 m Conservation Zone buffer was applied to specified fish bearing lakes
- A consistent 1 km Special Management buffer was applied to important creeks and rivers

As a result of community consultation feedback in Fort Good Hope, a number of changes have been made to the zoning in the K'asho Got'ine District.

Major changes between the former Draft 2 and the current Draft 3 are summarized below:

Little Chicago Special Management Zone (SMZ)	<ul style="list-style-type: none"> <li>▪ Boundaries were extended to include the farthest infrastructure site and heritage/cultural structures.</li> <li>▪ Zoning changed from conservation to special management to allow for continued use of the area's established infrastructure.</li> </ul>
3. Mackenzie River Special Management Zone (SMZ)	<ul style="list-style-type: none"> <li>▪ The SMZ buffer along the River was kept at 5 km.</li> <li>▪ Added protection for water through watershed based management.</li> </ul>
4. Ontaratue River Special Management Zone (SMZ) 6. Hare Indian River SMZ 7. Bluefish Creek to Tsintu River SMZ 8. Snafu Creek SMZ 12. Carcajou River SMZ	<ul style="list-style-type: none"> <li>▪ As requested during consultations, a number of large rivers and creeks were given a 1 km SMZ buffer for added ecological protection and to allow continued community use.</li> </ul>
5. Loon River to Fort Anderson Trail Special Management Zone (SMZ)	<ul style="list-style-type: none"> <li>▪ As requested during consultations, a 1 km SMZ buffer was applied along the trail.</li> </ul>
10. Norman Range Special Management Zone (SMZ)	<ul style="list-style-type: none"> <li>▪ This newly delineated SMZ encompasses Yamoga Rock, Chick Lake and Sam McRae Lakes. It extends into the Tulita District and creates a SMZ that protects a number of wildlife, cultural and harvest values.</li> </ul>
24. Travailant Uplands Conservation Zone (CZ) (Boil Betuwe, Manuel, Onhda, Yeltea Lakes)	<ul style="list-style-type: none"> <li>▪ As requested during consultations, 500 m conservation buffers were applied to the lakes.</li> </ul>
25. Fort Anderson Trail Lakes CZ (Loon, Rorey, Rond, Carcajou, Canot Lakes)	<ul style="list-style-type: none"> <li>▪ As requested during consultations, 500 m buffers were applied along each of the trail lakes.</li> </ul>
26. Colville Upland Lakes CZ (Burnt, Stump, Long, Stink, Trout)	<ul style="list-style-type: none"> <li>▪ As requested during consultations, 500 m buffers were applied around each lake.</li> </ul>
30. Anderson River Conservation Zone (CZ)	<ul style="list-style-type: none"> <li>▪ A consistent 1 km CZ buffer was applied to the length of the River and a 500 m buffer was applied to Whitefish Lake.</li> </ul>
36. Nerehtene Conservation Zone (CZ)	<ul style="list-style-type: none"> <li>▪ As requested during consultations, a new Conservation Zone was introduced at the crossing.</li> </ul>
37. Yamoga Rock Conservation Zone 38. Chick Lake CZ 40. Sam McRae Lake CZ	<ul style="list-style-type: none"> <li>▪ All three zones have a 500 m conservation buffer to protect ecological and cultural values. They all lie within a new zone, the Norman Range SMZ.</li> </ul>
